No. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs, Notification S.O.No.3267, dated 1st November, 1966, the Administrator, Union Territory, Chandigarh makes the following rules, regulating the method of recruitment to Group 'B' Technical post of Junior Engineer (Public Health) in respect of the office of the Superintending Engineer, Public Health Circle, Union Territory, Chandigarh Administration, Chandigarh namely:-

1. (i) Short title and commencement :- These rules may be called the Chandigarh Engineering Department (Group B) Junior Engineer (Public Health) of the office of Superintending Engineer, Public Health Circle, Union Territory, Chandigarh, Recruitment Rules, 2017.  
(ii) They shall come into force on the date of their publication in Chandigarh Administration Gazette.

2. Application:

These rules shall apply to the posts specified in Column No. 1 of the Schedule annexed to these rules.

3. NUMBER OF POSTS, CLASSIFICATION AND SCALES OF PAY:-

The number of the posts their classification and the scale of pay shall be specified in columns 2 to 4 of the said Schedule.

4. METHOD OF RECRUITMENT, AGE LIMIT AND QUALIFICATION, ETC:

The method of recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in Columns 5 to 13 of the said Schedule.

5. DISQUALIFICATION :-NO PERSON:-

- (a) Who has entered into or contracted a marriage with a person having a spouse living.

OR

- (b) Who having a spouse living, has entered into or contracted a marriage, with any person shall be eligible for the appointment to the said posts:

Provided that the Administrator, Union Territory, Chandigarh may, if satisfied that such marriage is permissible under the personal Law applicable to such person and other party to the marriage and there are other grounds for so doing, exempt, any person from the operation of this rule.

6. INITIAL CONSTITUTION:

Where there are officers already holding different categories of posts proposed to be included in the service on a regular / long term basis prior to the said notification of recruitment rules are protected for counting their regular service.

7. POWER TO RELAX:

Where the Administrator, Union Territory, Chandigarh is of the opinion that it is necessary or expedient so to do, he may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules in respect of any class or category of persons.

8. REPEAL & SAVINGS

Nothing in these rules shall effect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes/Scheduled Tribes/Other Backward Classes and Ex-Servicemen and other Special categories of person in accordance with the orders issued by the Chandigarh Administration, from time to time in this regard.

Further, the recruitment rules called Chandigarh Engineering Department (Group C) Junior Engineers (Public Health) as notified vide Notification bearing NO.A-2/2004/05 dated 25.06.2004 as amended vide<sup>3</sup> notification dated 01.07.2009 in so far as they are applicable to the members of the Service are hereby repealed.

Provided that any order issued or any action taken under the rules so repealed shall be deemed to have been issued or taken under the corresponding provisions of these rules.
