Subject: - Grant of Dearness Allowances - Revised rates effective from 01-01-2017.

In pursuance to the Govt. of India, Ministry of Finance, Department of Expenditure OM No.1/3/2017-E-II(B)(8) dated 30/3/2017(copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Allowance payable to State Government Employees shall be enhanced from the existing rate of 2% to 4% of the basic pay with effect from 1st January, 2017.

2. The Dearness Allowance payable under this order shall be paid in the following manner:-

- (i) The arrears pertaining to financial year 2016-17 shall be credited to GPF accounts of employees.
- (ii) The amount payable for current financial year shall be paid in cash to be credited to respective salary accounts.
- (iii) For NPS account holders, the arrears as well, will be paid in cash to be credited to their salary accounts.

3. The expenditure on account of this Dearness Allowance will be met from existing Budget provisions of the Department concerned in the Current Financial year 2017-18.

4. The revised rates of Dearness Allowance will be applicable to regular State Government employees only and will not apply to private /Non-Governmental institutions receiving grants-in-aids from the State Government.

4. The revised rates of Dearness Allowance will be applicable to regular State Government employees only and will not apply to private /Non- Governmental institutions receiving grants-in-aids from the State Government.
