The Committee would perform the following functions:-

1. To make suggestions for the promotion of Industry for balanced and harmonious growth and maintenance of Industrial Area, Chandigarh, keeping in view the overall ethos and character of the Union Territory, Chandigarh.
2. To make suggestions for the encouragement of entrepreneurship amongst new and existing entrepreneurs particularly among the economically weaker sections and women through training





- courses, seminars, and lectures involving Government Technical Training Institutes, Semi-Government Institutes, Public Sector Undertakings, Non-Government Organizations.
3. To encourage apprenticeship facility through private Industrial units and to safeguard interest of Industrial Workers.
  4. To recommend appointment of study groups and sub-Committees of various branches of studies as required from time to time and for carrying out the recommendations and decisions of these committees.
  5. To recommend on all other related policy matters such as Industrial infrastructure, Industrial incentives etc.
