**Public Notice**

In order to recruit the ten posts of the Assistant District Attorneys in the Law and Prosecution Department, U.T., Chandigarh, applications were invited and 403 applicants were prima-facie found eligible, who were called upon, to appear for the written test which was conducted in ITI, Sector 28, Chandigarh on 19.04.2015. Two more candidates were also allowed to participate in the written test provisionally as the Hon'ble Central Administrative Tribunal, Chandigarh Bench, Chandigarh vide its Interim Order dated 15.04.2015 passed in OA No. 060/313/2015 captioned as Anil Kumar Vs. Union of India and Ors. for the same and vide interim order 06.02.2015 passed by the Hon'ble High Court in Writ Petition CWP No. 1970 of 2015 captioned as Vikram Singh Nehra Vs. Chandigarh Administration and Ors. Out of the total 405 candidates, only 371 candidates appeared for the written test.

Since, the candidates were to be selected from General Category, OBC Category and SC Category, out of the aforesaid 405 candidates 32 candidates were initially called for Interview without disclosing their order of merit, to appear before the Selection Committee and their Interview was conducted by the Selection Committee 27.07.2015. Three times candidates against the advertised vacancies were called for Interview. The interview was of 20 marks. In total 32 candidates were called for Interview but out of the total 32, 31 candidates appeared, who gave the interview before the Selection Committee constituted for the said purpose.

The total marks secured by these 31 candidates i.e., (marks obtained in the written test of 160 marks + marks obtained in Interview of 20 marks + marks of qualification and total marks out of 200 marks) secured by these candidates are given below category wise i.e., General Category, OBC Category and SC Category.
