**Public Notice**

In order to fill up the three posts of the Steno-Typist (newly created, two for General category and one for OBC Category) the applications were invited. The appointment to the post of Steno Typist is governed by the Rules called as Chandigarh Administration Law & Prosecution Department (Group C Non Gazetted post) Rules, 2001. In response to the Public Notice issued for inviting application 103 applications in all were received and after scrutinizing One Hundred applicants prima facie found eligible in all who were called for the Stenography Test on 22.02.2015 at the ITI, Chandigarh. In the Stenography Test 76 candidates were appeared. Out of which 10 candidates named below have qualified the Stenography Test and obtained marks mentioned against each.


