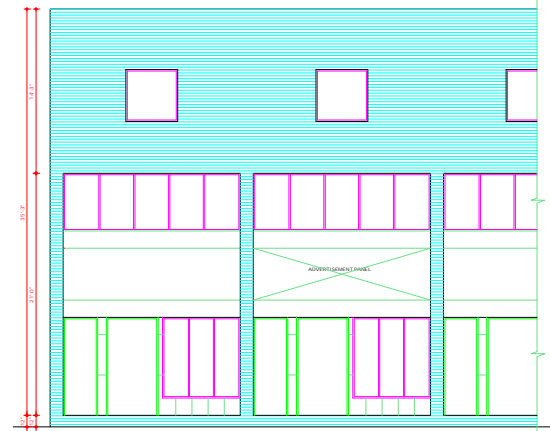
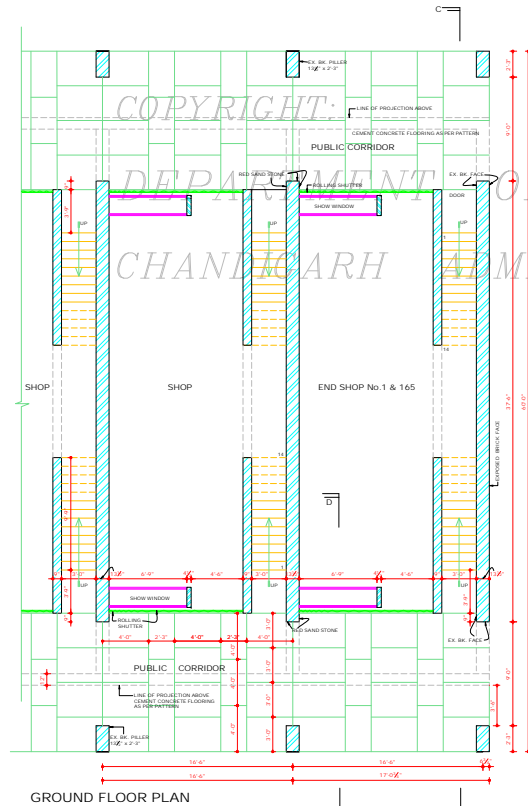


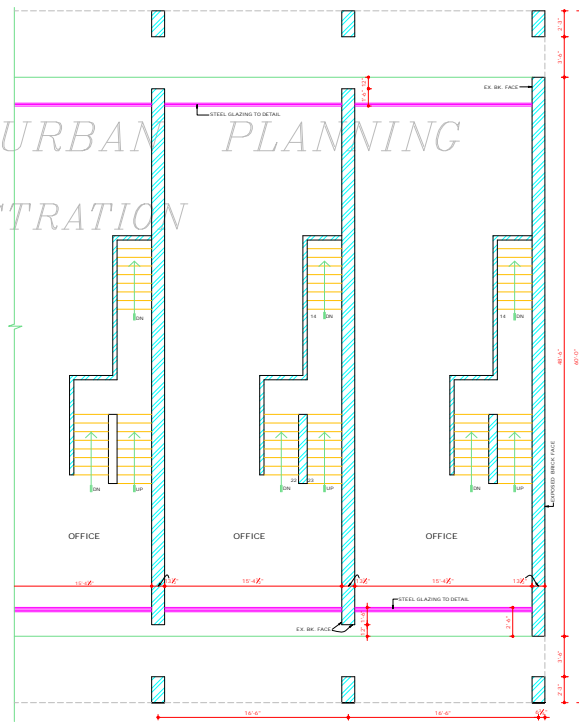
FRONT ELEVATION
